Grade 10 Sample Lesson Plan: Vicious Vapes

SOLs

- Research trends in teen use/abuse of alcohol, tobacco, and other drugs and their impact on the community.
- Evaluate the causal relationship between tobacco, alcohol, inhalant, and other drug use and chronic disease.
- Design an action plan to reduce risk-taking behaviors, acts of violence, substance use, and gang involvement

Objectives/Goals

- Students will be able to compare and contrast the medical facts from the the misinformation presented in the media
- Students will be able to analyze the reasons why there is so much misinformation in the media
- Students will be able to choose one of the vaping projects to create a health message about the susceptibility to injury and/or illness and adapt the message for high school students.

Procedure

Step 1	• Present the <u>Vicious Vapes Presentation</u> .	
Step 2	• Have students take notes on the harmful effects of vaping

Step 4	• Have students compare and contrast the medical facts from the presentation to the misinformation that the actress gave	
Step 5	• Have students brainstorm reasons why there is so much misinformation out in the media about e-cigarettes	
Step 6	• Have students choose one of the <u>Vaping</u> <u>Projects</u>


